

THE IMPACT OF A BEQUEST

A bequest is a wonderful way to give back to Mosman Art Gallery, and to have a significant impact on enriching our art-loving community with a legacy now and for future generations.

WHAT IS A BEQUEST?

A bequest is a gift made in a will for a nominated beneficiary. Bequests to Mosman Art Gallery can be made through:

- Shares, properties, artworks
- A specified sum of money – without a specific use, or directed to exhibitions, acquisitions, conservation programs, capital works, education and public programs
- A percentage of an estate

HOW DO I MAKE A BEQUEST?

Bequests enhance our collections, expand our programs and are an everlasting tribute to the generosity of our supporters. A bequest that is unrestricted is always the most helpful, and we recommend the following wording:

"I give to the Mosman Art Gallery ABN 94 414 022 939 (specific amount or percentage of estate or describe property or other assets) to be applied for the general purposes of Mosman Art Gallery and I direct that receipt from the Mosman Art Gallery shall be sufficient discharge of such a gift."

If you are considering leaving a specific work of art for our collection, we would welcome the opportunity to discuss your plans.

When making or updating your will, we recommend you seek independent legal advice to ensure it is legally valid and reflects your intentions.
